SC/ST/OBC Certificate, if applicable e. Migration Certificate (For Outsiders) F. Aadhar Card 2. Admission will be confirmed only after the submission of true copy of Marks Sheet and Original Leaving Certificate at the time of Payment of fees. 3. Newly admitted students should take a serious note of the following: a. The students should come in clean well ironed and complete uniform on all days of the week. b. At least 80% of attendance is required during the academic session. Students with less then 80% presence will not be allowed to appear for the final School exams or Board exams. c. Students are responsible to the School authorities for their behavior and conduct inside and outside the School premises. Hence any indiscipline or misconduct will justify an action taken against them. d. Any damage to the School property is liable to compensation or punishment. e. It is compulsory to follow School's rules & regulations. f. It is required that all the students should pass in all the internal as well as preliminary exams. g. It is compulsory for the parents to collect the results of their wards of all the exams in person. h. The students are encouraged for 100% participation in various activities and therefor adhere to it. 4.
